#### Social participation - NGOs

- Legally regulated processes
- Non regulated forms
  - Negotiation
  - Conciliation
  - Commentation
  - Commendation
  - Empowerment
  - Common decision



#### Difficulties:

- Absence of social assistence
  - Prejudication
  - False information
- Undefined forms of civil participartion
- Absence of an umbrella organisation
  - Minimal cooperation
- Problematic juridical position
  - Which ministry is the responsible?
- Communication problems
- Frequent changes in regulations





#### Practice 1.

- Ministry of Labour and Social Affairs and civil organizations: National Council of Vocational-training and Adult Education
  - Decision making, vocational concialation

- Problematic cooperation
  - No regulation on how and which civil organisations may nominate a delegate





#### Practice 2.

#### Ministry of Education and civil organizations:

- Council of Public Education
  - Each organization may nominate a delegate
  - Members of the Council are elected by the organizations





#### Practice 3.

### Ministry of Labour and Social Affairs: Adult Education Accreditation Board

- Institutional and programme accreditation
- Professional concialation
- Certain civil organizations, trade unions and professional associations nominate a delegate
- Members of the Board are appointed by the Minister for a period of three years





#### Practice 4.

Ministry of Education and Culture: Language Examination Accreditation Board

- Accreditation of examination systems and centers
- Professional concialation
- Individual professionals apply for membership
- Members of the Board are appointed by the Minister for a period of three years



#### **Conclusions:**

- Change the regulations
  - More concrete about the rights and obligations of the civil sector
  - Less bureaucratic
- Umbrella organisation for the civil sector
- More effective cooperation between the governmental and the civil sector
